#### 2 Abstract

This specification identifies the common Quote use cases and attributes needed to support intercarrier Quote management. It supports the requirements defined in the MEF Lifecycle Service Orchestration (LSO) Reference Architecture and Framework (MEF 55 [9], "LSO RA") requirements for Quotes over the Sonata Interface Reference Point(interactions between a Service Provider and a Partner). Information contained within this specification will be utilized by both Buyer and Seller for the development of automated API based interaction.

#### 3 Release Notes

This document is undergoing a review of the Call for Comments Ballot on this version of the document. There are no outstanding issues that are known at this time. All comments from the previous Call for Comments Ballot have been addressed in this version of the document. Based on the ongoing review, issues may be identified that will be addressed prior to the document proceeding to Letter Ballot.



#### 4 Terminology and Acronyms

This section defines the terms used in this specification. In many cases, the normative definitions to terms are found in other documents. In these cases, the third column is used to provide the reference that is controlling, in other MEF or external documents.

In addition, terms that are defined in MEF 10.3 [4], MEF 12.2 [5], MEF 26.2 [6], MEF 50.1 [7], MEF 51.1 [8], MEF 55 [9], MEF 57.1 [10], and MEF 79 [11] are included in this document by reference and are not repeated in the table below.

#### 5 Scope

This specification defines the process for MEF Quote Management between a Seller and Buyer. This specification is limited to the business process requirements depicted as Use Cases and attribute definitions needed for Quote Management.



#### 6 Compliance Levels


The key words "MUST", "MUST NOT", "REQUIRED", "SHALL", "SHALL NOT", "SHOULD", "SHOULD NOT", "RECOMMENDED", "NOT RECOMMENDED", "MAY", and "OPTIONAL" in this specification are to be interpreted as described in BCP 14 (RFC 2119, RFC 8174) when, and only when, they appear in all capitals, as shown here. All key words must be in bold text.

Items that are **REQUIRED** (contain the words **MUST** or **MUST NOT**) are labeled as **[Rx]** for required. Items that are **RECOMMENDED** (contain the words **SHOULD** or **SHOULD NOT**) are labeled as **[Dx]** for desirable. Items that are **OPTIONAL** (contain the words **MAY** or **OPTIONAL**) are labeled as **[Ox]** for optional.



#### 7 Introduction

This specification defines the business requirements and process-related guidelines for the Product Quote process over the Sonata Interface Reference Point. The Sonata Interface Reference Point is defined in MEF 55 [9] as the Management Interface Reference Point supporting the management and operations interactions (e.g. ordering, billing, trouble management, etc.) between two network providers (e.g. Service Provider Domain and Partner Domain). The scope of this specification is limited to interactions between these parties; within this specification, they are referred to as the "Buyer" and the "Seller". A Buyer is defined as the organization acting as the customer in a transaction over a Sonata Interface Reference Point (Service Provider <-> Partner). A Seller is defined as the organization acting as the supplier in a transaction over a Sonata Interface Reference Point (Service Provider <-> Partner).



#### Figure 1 – LSO Reference Architecture

Within this document the following terms are used with the definition as specified below:

Notification - A message sent from the Seller to the Buyer to inform them of an event that has occurred in regard to a specific instance of a POQ, Quote, or Order. The attributes that are contained within a notification are specified within this document.



Request - A message passed from one party to the other that initiates a process. The attributes that are contained within a request are specified within this document.

Response - A message returned by the party receiving the Request. The attributes that are contained within a response are specified within this document.

Immediate Quote Response - A Seller's response to the Buyer's Create Quote Request, whereby the Seller responds immediately with the results of the Create Quote Request or indicates that the request cannot be processed. The Seller's response includes Quote and Quote Item attributes as specified.

Deferred Quote Response - A Seller's response to a Buyer's Create Quote Request whereby the Seller immediately acknowledges that the Create Quote Request was received with a response that includes a minimum set of Quote and Quote Item attributes. Over time, the Seller sends notifications to update the Buyer on the status and a Quote with the results of the Create Quote Request (assuming the Buyer has subscribed to receive the notifications).

Quote – A Quote is considered provided to the Buyer by the Seller when the state of the Quote is one of the completion states as shown in section 10 and the state of each Quote Item is one of the following:

- ANSWERED
- ABANDONED
- INSUFFICIENT\_INFORMATION\_PROVIDED
- ORDERABLE
- ORDERABLE\_ALTERNATE
- UNABLE\_TO\_PROVIDE

The Buyer requests a quote for the delivery of one or more of the Seller's Product Offerings or for an action to be performed on an existing Product. The terms Product Offerings and Products are defined in MEF 79 [11]. For an installation, the Buyer references a Product Offering. If the Buyer is requesting a quote to change or disconnect one of their existing products that is in the Seller's product inventory, the Buyer references the Seller's Product Identifier. A Buyer might request a quote for a disconnect to determine if there are any termination charges.

There are 2 associated "patterns" of interaction between the Buyer and Seller when the Buyer issues a Quote request:

- 1. The Seller may respond immediately with the results of the request.
- 2. The Seller may acknowledge that the request has been received, but will not complete processing it immediately, and send notifications to update the Buyer on the status (assuming the Buyer has subscribed to receive the notifications).

Note: The Buyer may retrieve the Quote at any time to obtain status and details on the Quote.



The Seller may indicate process of the request is not possible (immediately or after initiating processing) if the Product Offering is not supported at a requested location, does not support the requested attributes, or for other exceptions.

A Buyer may request either a Budgetary or Firm Quote Level using the Buyer Requested Quote Level Quote attribute.

A Seller returns a Budgetary Quote if the Buyer requested a Budgetary Quote Level. All Quote Items in the Seller's Quote must be at the Budgetary level.

A Seller returns a Firm or Firm – Subject to Feasibility Check Quote if the Buyer requested a Firm Quote Level. All Quote Items in the Seller's Quote must be at either the Firm or Firm – Subject to Feasibility Check level.

A Budgetary Quote Level provides estimated charges for the product install, change, or disconnect. A Budgetary level quote might be requested by a Buyer during negotiations with a customer for a service. The Buyer is simply seeking a high-level estimate of the cost associated with the service. The Seller must return a Budgetary Quote if the Buyer requests a Budgetary Quote Level.

A Buyer requests a Firm Quote Level using the Buyer Requested Quote Level Quote attribute when committed charges are needed. As an example, if the Buyer is trying to provide pricing to an end customer, the Buyer may require firm MRC and if possible, NRCs to provide the end customer with committed pricing.

A Seller responds with a Firm Quote Level when committed MRCs and, where applicable, committed NRCs for the service install, change, or disconnect can be provided. When the Seller responds with a Firm Quote Level, this represents a commitment to the Buyer that the pricing will not change unless there are additional actions requested by the Buyer such as an Expedite request.

A Seller responds with a Firm – Subject to Feasibility Check Quote Level when they have completed all work that they are willing to perform. A Firm - Subject to Feasibility Check level allows the Seller to provide an indication of the pricing without the commitment of a Firm Quote Level. The Firm – Subject to Feasibility Check level Quote includes a committed MRC and a combination of committed and estimated NRCs. Additional NRCs may be added during fulfillment as costs are identified. This can only be done with quotes with the Quote Level of Firm – Subject to Feasibility Check.

When the Buyer Requested Quote Level in the Create Quote Request is Firm, there are two states related to the Quote that provide information to the Customer. These are the IN\_PROGRESS DRAFT ORDERABLE ALTERNATE The state and the state. IN\_PROGRESS\_DRAFT state is used by the Seller to provide a Quote that is not yet fully completed. It indicates that the Seller has provided some of the requested information from the Quote Request but has not fully completed their work on the Quote. A Quote in the IN\_PROGRESS\_DRAFT state may have a Quote Level of Budgetary or Firm - Subject to Feasibility Check. A Quote in the ORDERABLE\_ALTERNATE state indicates that the Seller has completed all the work on the Quote Request that they are willing to do. It indicates that the



Seller is not able to exactly match non-product configuration attributes (e.g., Term, Quote Level) of the Quote Request. A Quote in the ORDERABLE\_ALTERNATE state may have a Quote Level of Firm – Subject to Feasibility Check, or Firm. See section 10 for detailed definitions of these states.

To fully define the business interactions associated with inter-carrier quotes, this specification is focused on the following key areas:

- Quote Management Use Cases and Business Process Definitions
- Specific Quote Attributes supported in this specification
- Process Flows for Quotes and Quote Items
- Notifications of events that occur during processing of the Quote




#### 8 Quote Use Cases and Business Process Definitions

#### 8.1 High-Level Use Cases

This section provides the complete set of Use Cases needed to support Product Quote Management and expands on the quote process defined in MEF 50.1 [7]. These Use Cases are based on business process standards of interactions between Buyers and Sellers of Products. The specific attributes associated with each Use Case are defined in section 9. Prior arrangements for Buyer authentication, security verification, and system interface requirements are not addressed within these use cases. All onboarding requirements must be agreed to between the Buyer and Seller prior to applying the quote process described in the Use Cases described in this section.

The Buyer might have performed an Address or Site check or a Product Offering Qualification (POQ) as specified in MEF 79 [11] prior to the process of establishing a quote. The Seller may mandate that every request for an installation or change include an Address Identifier, Site Identifier, and/or POQ Identifier, and will reject the Quote request if those identifiers are not provided by the Buyer. The Quote functionality is not specific to any particular product, and thus the Buyer is able to get a quote on any of the Product Offerings available to the Buyer that are supported by the Seller. The characteristics of the product are found in its associated Product Specifications and Product Offerings.

Figure 2 shows the Sonata Pre-Order and Order functions:

- Address Validation
- Site Retrieval
- Product Offering Qualification
- Quote
- Product Order

The use cases within this document support Quote Management. Quote Management allows the Buyer to submit a request to find out how much the installation of an instance of a product offering, an update to an existing product, or a disconnect of an existing will cost. The Seller Quote contains the prices for each product or product offering included within the request.

The Buyer may request, and the Seller may offer either an Immediate response or a Deferred response. An Immediate response is returned quickly, normally < 30 seconds from receiving the request. The Immediate response includes the Seller's Quote. A Deferred response allows the Seller some time period, days, weeks, etc., to complete the request. For a Deferred response, the Seller responds immediately with the attributes specified in this document and then provides



notifications to update the status of the quote process. The Buyer can identify in their request and the Seller can offer either an Immediate response or a Deferred response.

#### 8.2 **Quote Use Cases**

This section defines the use cases that support Quote Management.




Figure 3 – Quote Use Cases

The Buyer being on-boarded with the Seller is a Pre-Condition for all Use Cases. The on-boarding process includes the Buyer and Seller agreeing to several items including the language used for communication between the parties and the currency type used for price information.

- **[D1]** For all Addresses that have not been validated, a Buyer **SHOULD** initiate a Validate Address request, to get the Seller's full details associated with this Address prior to submitting a Create Quote Request.
- **[D2]** For all Addresses that have been validated, the Buyer **SHOULD** use the Seller's Address Identifier to describe the location when submitting a Create Quote Request and a Service Site Identifier does not exist.

A Seller assigns a Site Identifier to an address at some point in the POQ, Quote, or Order process. This is dependent upon the Seller and their processes. If a Site Identifier has been assigned by the Seller then the following requirements ([D3], [D4]) apply.



- **[D3]** After validating an Address, a Buyer **SHOULD** initiate a Retrieve Service Site List request and obtain the Seller's Service Site Identifiers for all Service Sites the validated Address prior to submitting a Create Quote Request.
- [D4] Once the Buyer has obtained the Service Site list, then for all subsequent operations related to this Service Site, the Buyer SHOULD use the Seller's Service Site Identifier to reference this Service Site when submitting a Create Quote Request.

Each Related Product Identifier may be specified by the Buyer as a list of one or more items. The Related Product Identifiers that may be included are defined in the Product Specification. When the Buyer provides a list, the Seller processes the list as defined in the Product Specification. From the list of values provided by the Buyer, the Seller is able to return the best result for the Quote Request over any of the Related Product Identifiers in the list.

The Buyer's request and the Seller's response and Quote are defined in the following sections.



#### 9.2.1 Buyer Create Quote Request

9.2.1.1 This section contains the Service Attributes and requirements for Use Case 1a, 1b, and 1c. Common Requirements

The requirements that are common to all Quote Item Product Actions are defined in this section.

- [**R11**] The Seller **MUST** support either Use Case 1a or 1b.
- **[O2]** The Seller **MAY** support Use Cases 1a, 1b, and 1c.
- [**R12**] A Buyer **MUST** include at least one Quote Item in a Create Quote Request.
- **[R13]** A Buyer requesting a Quote **MUST** include the following attributes as defined in Table 14:
  - Buyer Requested Quote Level
  - Quote Item(s)
  - Immediate Quote Response
- **[O3]** The Buyer **MAY** include the Agreement attribute as defined in Table 15.
- **[R14]** The Buyer **MUST** specify the following attributes in Table 15 for each Quote Item in the Buyer Create Quote Request:
  - Quote Item Reference Number
  - Quote Item Product Action
- **[R15]** If the Immediate Quote Response is FALSE, the Buyer **MUST** include the Quote Item Technical Contact Information attribute in Table 15 for each Quote Item in the Buyer's Create Quote Request.
- **[R16]** If the Immediate Quote Response is FALSE, the Buyer **MUST** include the Buyer Contact Information.
- [**R17**] If the Buyer Create Quote Request specifies the Immediate Quote Response of FALSE the Buyer **MUST** specify the Requested Quote Completion Date defined in Table 14.
- **[R18]** If the Buyer has specified Immediate Quote Response to be TRUE, then the Seller **MUST** ignore the Requested Quote Completion Date attribute if it is specified by the Buyer.
- [O4] The Seller MAY make the POQ Identifier mandatory for a Buyer Create Quote Request.

[CR1]<[O4] The Buyer **MUST** provide the valid POQ and POQ Item Identifier(s) in the Quote Request as defined in Table 23 if required by the Seller.



#### 9.2.1.2 Quote Item Product Action – INSTALL

- [**R19**] The Buyer Create Quote Request **MUST** include the following attributes for each Quote Item as defined in Table 15 when Quote Item Product Action is INSTALL:
  - Product Offering Identifier
  - Product Specific Attributes
- [O5] The Buyer Create Quote Request MAY include the following attributes for each Quote Item as defined in Table 15 when Quote Item Product Action is INSTALL:
  - Requested Quote Item Installation Interval
  - Quote Item Deal Reference
  - [CR2]<[O5] If the Buyer includes the Requested Quote Item Installation Interval in the Create Quote Request and they completed a POQ prior to submitting the Create Quote Request, the Requested Quote Item Installation Interval **MUST** be longer or equal to the interval returned in the referenced POQ.

Note: if the Buyer includes the Requested Quote Item Installation Interval in the Create Quote Request and they have not completed a POQ prior to submitting the Create Quote Request, the Requested Quote Item Installation Interval may be any value allowed by the Seller.

- **[R20]** If the request includes a Quote Item that refers to a Product Offering for which a location is required, the Buyer Create Quote Request **MUST** include the Place Relationship attributes.
- **[R21]** If the Buyer provides a Place Relationship, it **MUST** comply with the format agreed to by the Buyer and Seller during the on-boarding process.
- **[R22]** If the Quote Item requires a location and the Immediate Quote Response is FALSE, the Buyer **MUST** include the Quote Item Location Contact Information for that Quote Item.
- **[R23]** If the Buyer desires to select an Alternate Product that was proposed in the POQ response, they **MUST** include a valid POQ Item Identifier and Alternate Product Proposal Identifier attribute in Table 23.
- **[R24]** If the Buyer does not desire to select an Alternate Product in their Create Quote Request, they **MUST NOT** include the Alternate Product Proposal Identifier attribute in Table 23.
- **[R25]** If Quote Item Product Action is INSTALL, the Buyer **MUST NOT** specify the Product Identifier attribute in Table 15.
- [O6] The Buyer Create Quote Request MAY contain any of the other attributes in Table 15 marked as Set by Buyer.



#### 9.2.1.3 Quote Item Product Action - CHANGE

- **[R26]** The Buyer Create Quote Request **MUST** include the following for each Quote Item as defined in Table 15 when Quote Item Product Action is CHANGE:
  - Product Identifier
- [**R27**] If the Quote Item Product Action is CHANGE, the Buyer Create Quote Request **MUST** include the following for each Quote Item as defined in Table 15
  - Product Specific Attributes
- [07] The Buyer Create Quote Request MAY include the following attributes for each Quote Item as defined in Table 15 when Quote Item Product Action is CHANGE:
- [CR3] $\leq$ [O7] Requested Quote Item Installation Interval If the Buyer includes the Requested Quote Item Installation Interval in the Create Quote Request, they **MUST** be  $\geq$  to the interval returned in the referenced POQ.

Note: if the Buyer includes the Requested Quote Item Installation Interval in the Create Quote Request and they have not completed a POQ prior to submitting the Create Quote Request, the Requested Quote Item Installation Interval may be any value allowed by the Seller.

#### 9.2.1.4 Quote Item Product Action – DISCONNECT

- **[R28]** The Buyer Create Quote Request **MUST** include the following for each Quote Item as defined in Table 15 when Quote Item Product Action is DISCONNECT:
  - Product Identifier
- **[R29]** If the Quote Item Product Action is DISCONNECT, the Buyer **MUST** specify the Product Identifier as described in Table 15.
- **[R30]** If the Quote Item Product Action is DISCONNECT, the Buyer **MUST NOT** specify the following attributes in Table 15:
  - Product Offering Identifier
  - Product Specific Attributes
  - Product Relationships
  - Quote Item Place Relationship
  - Quote Item Location Contact
  - Quote Item Relationship



**[R31]** The Requested Quote Item Installation Interval **MUST** be  $\geq$  the Installation Interval identified in the referenced POQ via the Installation Interval Unit and the Installation Interval Value as described in MEF 79 [11].

Note: if the Buyer includes the Requested Quote Item Installation Interval in the Create Quote Request and they have not completed a POQ prior to submitting the Create Quote Request, the Requested Quote Item Installation Interval may be any value allowed by the Seller.

### 9.2.2 Seller Request Quote Response and Quote Attributes

The Seller responds to the Buyer's Create Quote Request.

If the Immediate Quote Response is TRUE in the Buyer's Create Quote Request, the Seller's response includes the Seller's Quote including the Seller's Quote Identifier.

If the Immediate Quote Response is FALSE in the Buyer's Create Quote Request and the Seller is providing a deferred response (see section 7), the Seller's response includes at least the Seller's Quote Identifier and the Seller provides their Quote at a later time. The Buyer retrieves the Quote using the Retrieve Quote by Quote Identifier function.

If the Immediate Quote Response is FALSE in the Buyer's Create Quote Request and the Seller opts to provide an immediate response, the response includes their Quote including the Seller's Quote Identifier. This section contains the attributes with which the Seller answers the Buyer's Create Quote Request.

### 9.2.2.1 Common Requirements for Immediate and Deferred Response

**[R32]** When providing a response to a Quote Request the Seller **MUST** specify the Seller Response Code attribute shown in Table 13.

The following requirements apply if the Seller Response Code does not indicate success.

**[R33]** If the Seller Response Code does not indicate success, the Seller **MUST NOT** specify any of the following attributes in Table 14 in the response: Quote Identifier, Quote State, Seller Contact Information, and Quote Items.

The following requirements apply when the Seller Response Code indicates success.

- **[R34]** When providing a response to a Quote Request, the Seller **MUST** specify the Seller Quote Identifier attribute in Table 14 in the response.
- **[R35]** The Seller's Quote **MUST** echo back all attributes and values set by the Buyer in their Create Quote Request.
- [R36] The Seller's Quote MUST contain each Quote Item in the Buyer's Create Quote Request.



- [R37] For a Create Quote Request with a Buyer Requested Quote Level of FIRM, the Seller's Quote MUST contain the Quote Level which is either FIRM or FIRM\_SUBJECT\_TO\_FEASIBILITY\_CHECK.
- **[R38]** The Seller's Quote Level **MUST** be FIRM-SUBJECT\_TO\_FEASIBILITY\_CHECK if any of the Quote Item's Subject to Feasibility Check attribute is set to TRUE.
- **[R39]** For a Create Quote Request with a Buyer Requested Quote Level of BUDGETARY, the Seller's Quote **MUST** contain a Quote Level of BUDGETARY.
- [**R40**] The Seller **MUST** specify the Seller Contact Information attribute in Table 14 in the Quote.
- **[R41]** The Seller **MUST** specify the Quote Item Reference Number attribute in Table 15 in their Quote. This number **MUST** match precisely one of the Quote Item Reference Numbers provided by the Buyer in the Create Quote Request.
- [R42] Each Quote Item in the Seller's Quote MUST correspond to one and only one Quote Item in the Buyer's Create Quote Request.
- **[R43]** The Seller **MUST** specify the Quote Item State attribute in Table 15 in their Quote as described in section 10.
- **[R44]** If the Quote Level is FIRM-SUBJECT\_TO\_FEASIBILITY\_CHECK, the Seller **MUST** specify the Subject to Feasibility Check attribute in Table 15 in their Quote for each Quote Item.
- [R45] If the Buyer's Create Quote Request contains a Requested Quote Item Installation Interval, the Seller's Quote MUST contain a Quote Item Installation Interval that is ≤ the Buyer's Requested Quote Item Installation Interval if the Quote Item State is ORDERABLE or ANSWERED.
- [R46] If the Buyer's Create Quote Request contains a Requested Quote Item Installation Interval and the Seller's Quote MUST contains a Quote Item Installation Interval that is > the Buyer's Requested Quote Item Installation Interval the Quote Item State is ORDERABLE\_ALTERNATE.
- **[R47]** If the Buyer's Create Quote Request does not contain a Requested Quote Item Installation Interval the Seller's Quote **MUST** contain a Quote Item Installation Interval when the Quote state is ANSWERED, ORDERABLE, or ORDERABLE\_ALTERNATE.
- **[R48]** When a Quote moves to the ORDERABLE\_ALTERNATE state, the Seller **MUST** make available the information contained within Table 14 available.
- [R49] If the Seller's Quote is in UNABLE\_TO\_PROVIDE, INSUFFICIENT\_INFORMATION\_PROVIDED, ANSWERED, ORDERABLE, ORDERABLE\_ALTERNATE, or CANCELLED state, all Quote Items within the Quote Request MUST be in a terminal state.



- [R50] If the Seller is unable to provide a Quote for a Quote Item that matches the Requested Quote Level, the Seller MUST set the Quote Item State attribute to UNABLE\_TO\_PROVIDE.
- **[R51]** If the Quote Item State Attribute is INSUFFICIENT\_INFORMATION\_PROVIDED or ABANDONED, the Seller **MUST NOT** specify the following attributes in Table 15 :
  - Installation Interval
- [R52] If the Quote Item State is INSUFFICIENT\_INFORMATION\_PROVIDED, the Seller MUST specify the Termination Error attribute as specified in Table 15.

The following requirements apply to pricing as shown in Table 17, Table 18, and Table 25 and apply only if the Seller Response Code indicates success.

- [R53] The Seller MUST provide a Quote Item Price for each Quote Item in IN\_PROGRESS\_DRAFT, ANSWERED, ORDERABLE, or ORDERABLE\_ALTERNATE state including the following attributes shown in Table 18 and Table 25:
  - Quote Item Price Name
  - Quote Item Price Type
  - Quote Item Price
  - Price Duty Free Amount
- [O8] The Seller MAY provide a Quote Item Price for each Quote Item in IN\_PROGRESS\_DRAFT, ANSWERED, ORDERABLE, or ORDERABLE\_ALTERNATE state including the following attributes shown in Table 25:
  - Price Tax Rate
  - Price Tax Included Amount
- **[R54]** If the Quote state is ORDERABLE and the state of all Quote Items is ORDERABLE the Seller **MUST** provide a Price Duty Free Amount for each Quote Item as shown in Table 25.
- **[R55]** If the Quote Item Price Type is RECURRING, the Seller **MUST** include the Quote Item Price Recurring Charge Period in their response.
- **[R56]** Table 29 shows the combination of attributes that **MUST** be provided for each Price Type.

- [**R57**] If the Seller's Quote includes a Price Type of USAGE\_BASED for a Quote Item, it **MUST** include the attributes shown in Table 17 for that Quote Item.
- **[R58]** If the Seller's Quote includes a Seller End of Term Action of Roll for a Quote Item, then the Seller **MUST** specify the Roll Interval as shown in Table 17 for that Quote Item.
- [R59] If the Seller's Quote includes a Seller End of Term Action of Auto-disconnect or Autorenew, then the Seller MUST NOT specify the Roll Interval as shown in Table 17 for that Quote Item.
- **[D5]** The grace period after auto-renewal during which the Buyer can disconnect the Product without penalty **SHOULD** be agreed between Seller and Buyer as part of on-boarding if the Seller chooses to use the value "Auto-renew" for the Seller End of Term Action attribute.

#### 9.2.2.2 Requirements for Request with Immediate Response = TRUE Seller Provides Immediate Response

The following requirements apply if the Seller Response Code indicates success.

- [**R60**] When providing a response to a Quote Request with an Immediate Quote Response of TRUE, the Seller **MUST** include their Quote in the response.
- [R61] When providing a response to a Quote Request with an Immediate Quote Response of TRUE, the Seller MUST specify the Quote State attribute in Table 14 in the Quote. This MUST be either ANSWERED, ORDERABLE, ORDERABLE\_ALTERNATE, UNABLE\_TO\_PROVIDE, or INSUFFICIENT\_INFORMATION\_PROVIDED.
- [R62] When providing a response to a Quote Request with an Immediate Quote Response of TRUE and the Quote state indicates ORDERABLE or ORDERABLE\_ALTERNATE, then for each Quote Item in the request, the Seller MUST specify the Quote Items attribute in Table 15 in the Quote.



- [R63] If the Quote state indicates ORDERABLE\_ALTERNATE at least one of the Quote Items MUST indicate a Quote Item State of ORDERABLE\_ALTERNATE.
- [R64] When providing a response to a Quote Request with an Immediate Quote Response of TRUE and the Quote state indicates ORDERABLE or ORDERABLE\_ALTERNATE, then for each Quote Item which has recurring charges, the Seller MUST specify the Seller End of Term Action of Roll, Auto-disconnect, or Auto-renew as shown in Table 17.
- [R65] When providing a response to a Quote Request with an Immediate Quote Response of TRUE and the Quote state indicates ORDERABLE, then for each Quote Item in the request, the Seller MUST specify the Quote Items attribute in Table 15 in the Quote and all of those Quote Items MUST indicate a Quote Item State of ORDERABLE.
- [R66] When providing a response to a Quote Request with an Immediate Quote Response of TRUE and the Quote state indicates INSUFFICIENT\_INFORMATION\_PROVIDED, then for at least one of the Quote Items in the request, the Quote Item State MUST be INSUFFICIENT\_INFORMATION\_PROVIDED.
- **[R67]** If the Buyer's Quote Request contains a Requested Quote Item Installation Interval the Seller's response to a Quote Request with an Immediate Quote Response of TRUE and a state of ORDERABLE **MUST** include a Quote Item Installation Interval that is  $\leq$  the Buyer's Requested Quote Item Installation Interval for that Quote Item.
- [O9] If the Buyer's Quote Request contains a Requested Quote Item Installation Interval the Seller's response to a Quote Request with an Immediate Quote Response of TRUE and a state of ORDERABLE\_ALTERNATE MAY include an Quote Item Installation Interval that is > the Buyer's Requested Quote Item Installation Interval for that Quote Item.

# 9.2.2.3 Requirements for Request with Immediate Response = FALSE Seller Provides Deferred Response

The following requirements apply if the Seller Response Code indicates success.

- [R68] When providing an Deferred response to a Quote Request with an Immediate Quote Response of FALSE and the Quote state indicates ORDERABLE or ORDERABLE\_ALTERNATE, then for each Quote Item in the request, the Seller MUST specify the Quote Items attribute in Table 15 in the Quote.
- [R69] If the Quote state indicates ORDERABLE\_ALTERNATE at least one of the Quote Items MUST indicate a Quote Item State of ORDERABLE\_ALTERNATE.
- **[R70]** The Seller's Quote with an Immediate Quote Response of FALSE that has moved to the ORDERABLE state **MUST** include a Quote Item Installation Interval that is  $\leq$  the Buyer's Requested Order Item Installation Interval.



- **[R71]** If the Seller's Quote with an Immediate Quote Response of FALSE contains an Order Item Installation Interval that is > the Buyer's Requested Quote Item Installation Interval the Quote **MUST** be moved to the ORDERABLE\_ALTERNATE state.
- **[R72]** If the Seller's Quote with an Immediate Quote Response of FALSE moves to the ANSWERED state, the Seller **MUST** make available the information contained in Table 15.

# 9.2.2.4 Requirements Request with Immediate Response = FALSE Seller Provides Immediate Response

The following requirements apply if the Seller Response Code indicates success.

- [**R73**] When providing a Quote with an Immediate Quote Response of FALSE and the Seller is providing an Immediate Quote Response, the Seller **MUST** specify the Quote State attribute in Table 14 in the Quote. This **MUST** be either ANSWERED, ORDERABLE, ORDERABLE\_ALTERNATE, UNABLE\_TO\_PROVIDE, or INSUFFICIENT\_INFORMATION\_PROVIDED.
- [R74] When providing a Quote with an Immediate Quote Response of FALSE and the Seller is providing an Immediate Quote Response and the Quote state indicates ORDERABLE\_ALTERNATE, then for each Quote Item in the request, the Seller MUST specify the Quote Items attributes in Table 15, in the Quote and at least one of the Quote Items MUST indicate a Quote Item State of ORDERABLE\_ALTERNATE.
- [R75] When providing a Quote with an Immediate Quote Response of FALSE and the Seller is providing an Immediate Quote Response and the Quote state indicates ORDERABLE, then for each Quote Item in the request, the Seller MUST specify the Quote Items attribute in Table 15, in the response and all of those Quote Items MUST indicate a Quote Item State of ORDERABLE.
- [**R**76] When providing a Quote with an Immediate Quote Response of FALSE and the Seller is providing an Immediate Quote Response and the Quote state indicates INSUFFICIENT INFORMATION PROVIDED, then for at least one of the Quote Items in the request, the Seller **MUST** specify the Quote Items attribute in Table 15, in the response that indicates Ouote Item State of а INSUFFICIENT\_INFORMATION\_PROVIDED. In this case, the Seller Quote MUST provide details for each Quote Item in this Create Quote Request.

# 9.3 Cancel or Reject Quote

The Buyer may Cancel a Quote Request that is in progress or may Reject a Quote Response that the Seller has provided. The requirements are the same for both a Cancel Request and a Reject Request. A Buyer creates a Cancel or Reject Quote Request. The Seller does not need to respond with an Accept or Reject. Instead, it is inferred that if the Seller does not return an error, that the request has been accepted.



#### 9.3.1 Buyer Create Cancel or Reject Request

This section contains the Quote Attributes and requirements for Use Case 4 and Use Case 5. Table 16 contains the attributes that the Buyer may set in the Create Cancel or Reject Request.

- **[R77]** A Buyer requesting to Cancel, or Reject a Quote **MUST** include the following attributes as defined in Table 16:
  - Seller Quote Identifier
  - Requested Quote State
- [O10] The Buyer Cancel or Reject Quote Request MAY specify the reason attribute in Table 16.

#### 9.3.2 Seller Create Cancel or Reject Request Response

This section defines the attributes and requirements for the Seller's response to a Create Cancel or Reject Request. If the response does not include an error, the request is considered accepted and the Seller takes the appropriate action on the Quote.

**[R78]** When providing a response to a Buyer Create Cancel or Reject Request, the Seller **MUST** specify the Seller Response Code attribute shown in Table 13.

#### 9.4 Retrieve Quote List

The Buyer's request and the Seller's response are defined in the following sections.

#### 9.4.1 Buyer's Retrieve Quote List Request

This section contains the Quote Attributes and requirements for Use Case 2. Table 13 Table 14 contains the attributes that the Buyer may set in the Retrieve Quote List Request.

- [O11] The Buyer MAY use any of the following filter criteria specified in Table 13 for a Retrieve Quote List request:
  - Seller ID
  - Buyer ID
- [O12] The Buyer MAY use any of the following filter criteria specified in Table 14 for a Retrieve Quote List request:
  - Buyer Quote Identifier
  - Requested Quote Completion Date (range of dates)
  - Quote Request Date (range of dates)



- Quote Completion Date (range of dates)
- Quote State
- Quote Level
- Expected Quote Completion Date (range of dates)
- Buyer Project Identifier
- [O13] The Buyer MAY use a combination of filter criteria to avoid getting a Too Many Records response code.

#### 9.4.2 Seller Response to Retrieve Quote List Request

The Seller responds to the Retrieve Quote List request with the attributes shown in Table 13 and Table 14.

- **[R79]** The Seller's response to the Buyer's Retrieve Quote List request **MUST** contain the following from Table 13 and Table 14 for each Quote Identifier that matches the filter criteria:
  - Seller ID
  - Buyer ID
  - Seller Response Code
  - Quote Identifier
  - Buyer Quote Identifier
  - Quote Request Date
  - Quote Completion Date
  - Quote Completion State
  - Quote State
  - Quote Level
  - Expected Quote Completion Date
  - Buyer Project Identifier
  - Requested Quote Completion Date



**[R80]** If the Seller Response Code does not indicate success, the Seller **MUST NOT** reply with any of the attributes in Table 14.

#### 9.5 Retrieve Quote by Quote Identifier

The Buyer's request and the Seller's response for Use Case 3 are shown in the following sections.

#### 9.5.1 Buyer Retrieve Quote by Quote Identifier Request

The Buyer's request uses the Quote Identifier attribute from Table 14.

**[R81]** The Buyer **MUST** include the Quote Identifier as specified in Table 14 in their Retrieve Quote by Quote Identifier request.

#### 9.5.2 Seller Response to Retrieve Quote by Quote Identifier Request

The attributes with which the Seller responds to the Buyer's Retrieve Quote by Quote Identifier Request are shown in this section.

- **[R83]** If the Seller Response Code does not indicate success, the Seller **MUST NOT** specify any of the following attributes in Table 14 in the response: Quote Identifier, Quote State, Seller Contact Information, and Quote Items.
- **[R84]** If the Seller Response Code indicates success, the Seller's response to a Buyer Retrieve Quote by Quote Identifier request with a Quote Level = FIRM, the Seller **MUST** specify the attributes as shown in Table 30.
- **[R85]** If the Seller Response Code indicates success, the Seller's response to a Buyer Retrieve Quote by Quote Identifier request with a Quote Level = BUDGETARY, the Seller **MUST** specify the attributes as shown in Table 31.
- **[R86]** Each Quote Item in the Seller's response **MUST** correspond to one and only one Quote Item in the Buyer's Create Quote Request.

#### 9.6 Register for Quote Notifications

#### 9.6.1 Buyer Register for Notification Request

The Buyer's request uses the attributes from Table 26.

- **[R92]** When making a Register for Notification request, the Buyer **MUST** specify the Notification Target Information, List of Notification Types, and Action attributes shown in Table 26.
- **[R93]** If the Action attribute is START, the Buyer **MUST** specify the List of Notification Types to be started.
- **[R94]** If the Action attribute is STOP, the Buyer **MUST** specify the List of Notification Types to be stopped.

#### 9.6.2 Seller Response to a Register for Notification Request

The Seller's response to a Buyer's Register for Notification request uses the Seller Response Code from Table 13.

**[R95]** When responding to a Quote notification request, the Seller **MUST** specify the Seller Response Code attribute shown in Table 13.

### 9.7 Quote Notification

This section contains the Attributes and requirements for Use Case 7 as shown in Table 27. The following requirements apply to the Seller Quote Notification.

- [O14] The Seller MAY support Quote Notifications.
- [CR4]<[O14]The Seller **MUST** be able to send Quote Notifications to Buyers for both Immediate Quote Responses and Deferred Quote Notifications.
- [CR5]<[O14]Quote Notifications for Immediate Quote Responses **MUST** indicate when a quote has changed from the ORDERABLE\_ALTERNATE or ORDERABLE states to one of the end states (REJECTED, EXPIRED, or ACCEPTED).
- [CR6]<[O14]The Seller **MUST NOT** send Quote Notifications to Buyers who have not registered for Quote Notifications.



[CR7]<[O14]The Seller **MUST** send Quote Notifications to Buyers who have registered for Quote Notifications.

[CR8]<[O14]Quote Notifications **MUST** include the Attributes shown in Table 27.

# **10** Process Flows

# 10.1 Quote Process Flow

The Quote process flows are shown below. The diagrams capture various states that the Quote goes through in its lifecycle. The specific states are managed by the Seller based on its processing and/or based on Buyer's action. If the Buyer subscribes to Quote state change notifications, they will receive a notification every time the state changes.

- **[R96]** For a Quote with a Quote Level of FIRM, the Seller **MUST** support Quote states and their associated state transitions as shown in Figure 3 and Table 32.
- **[R97]** For a Quote with a Quote Level of BUDGETARY, the Seller **MUST** support Quote states and their associated state transitions as shown in Figure 5 and Table 33.
- **[R98]** For a Quote with a Quote Level of FIRM the Seller **MUST** support Quote Item states, and their associated state transitions shown in, Figure 6 and Table 33, Table 34.
- **[R99]** For a Quote with a Quote Level of BUDGETARY the Seller **MUST** support Quote Item states, and their associated state transitions shown in Figure 7 Table 34Table 35.




Figure 4 – FIRM Buyer Quote Level Quote Process Flow




Figure 5 – BUDGETARY Buyer Quote Level Quote Process Flow

### 10.2 Quote Item Process Flow

There are two Quote Item process flows. One when the Buyer Requested Quote Level is BUDGETARY and one when the Buyer Requested Quote Level is FIRM. These are shown below. The diagrams capture various states that the Quote Item goes through in its lifecycle. The specific states are managed by the Seller based on its processing and/or based on Buyer's action.




Figure 6 – BUDGETARY Buyer Requested Quote Level Quote Item Process Flow




Figure 7 – FIRM Buyer Requested Quote Level Quote Item Process Flow
